

STEP-BY-STEP ONLINE HEALTH INFORMATION REVIEW

For the 2023-24 school year, student health conditions, physical exams, hearing and vision screenings, and immunization records can be viewed in the Skyward Family Access system. During Online Registration, families will need to review and confirm health conditions and vaccination information. You can follow these steps to access your child's health information within Skyward Family Access.

13) If your child is **Out of Compliance** on any vaccinations, please submit their vaccination dates in one of these ways:

- a. Email your child's name, date of birth, and immunization record to ErnserJ@oasd.org
- b. Fax your child's name, date of birth, and immunization record to (262)-560-2106. Your medical provider can fax this information as well.
- c. Print the Student Immunization Record available on the WI Department of Health Services website: <u>https://www.dhs.wisconsin.gov/library/F-04020L.htm</u>. Then fill in the information and submit the form in one of these ways:

- d. If you choose to sign a waiver for religious, health, or personal conviction reasons, the bottom portion of the Student Immunization Record has been designated for this purpose. Simply check the type of waiver, indicate which immunizations are being waived, sign, and return to the OASD. In the event of an outbreak of a vaccine preventable disease, students with waivers may be excluded from school until the outbreak subsides.
